The Gwydir Resource Assessment, for the period from *31 October 2010 to 6 December 2010*, has provided **204.49 GL** to be distributed in accordance with the Water Sharing Plan for the Gwydir Regulated River Water Source.

This assessment provides that 133.96 GL can be distributed to the General Security Irrigation account and 11.84 GL can be distributed to the ECA account.

Accordingly, an available water determination of 0.2629 ML per unit share will be credited to Gwydir general security access licences effective from 6 December 2010.
